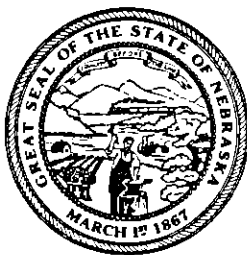

### MINUTES

Meeting of October 12, 2006

The meeting was called to order by Chairman John Gale at 9:05 A.M. on October 12, 2006, in Room 1507 of the State Capitol, Lincoln, Nebraska.

Chairman Gale introduced and swore in new member Mr. Timothy Loewenstein, representing the general public.

NITC standards. Mr. Ptacek indicated Polk County has been advised of this requirement. Mr. Ptacek indicated Mr. Bidrowski, NSRB Project Manager under contract, will address the Johnson County grant later in this meeting under agenda item 11. c.

Mr. Ptacek reported on the NSRB Cash Fund Balance. He indicated the Cash Fund Report is incomplete due to problems which arose when the Secretary of State Controller left and a new Controller hired. Ms. Susie Hinzman, Secretary of State Controller, and the Department of Administrative Services Accounting Division are working diligently to resolves these issues. Mr. Ptacek will notify Board members via email when all issues are resolved and a report is completed.

Mr. Ptacek reported on the Grant Status Report, the Reinvested Revenue Report, and the Unused Grant Monies Report. Mr. Ptacek indicated Mr. Bidrowski will be addressing some of the 'no activity' projects later in this meeting and Mr. Brian Stevenson will be addressing One-Stop Business Registration later in the meeting.

Mr. Freimuth motioned to move the University of Nebraska Library unused grant money to the NE State Historical Society for use in their Digital Archives feasibility study; motion was not seconded. Mr. Freimuth made a new motion to request the NSRB to contact the University of Nebraska Library to request they collaborate with the NE State Historical Society on their two grant projects; motion seconded by Mr. Loewenstein.

Chairman Gale called a recess at 10:35 A.M.

Chairman Gale reconvened the meeting at 10:50 A.M.

Chairman Gale reported Mr. Bill Bidrowski was hired as a project manager contractor and is working for the Board in that capacity. He also reported Ms. Brenda Decker (CIO) and Mr. Ron Moravec are nearing the completion of a proposal to the Board regarding a technical business analyst support contractor. Chairman Gale distributed a document explaining the Governor's appointment process for Boards and Commissions.

Mr. Ron Moravec, Chief Deputy Secretary of State, gave the General Counsel's Report. He confirmed that he and Ms. Decker are close to a final draft of an agreement for the Board's approval regarding technical support analysis.

Mr. Moravec reported the 2001-2002 Cookie Policy adopted by the Board cannot be located and recommended the Board repeal the 2001-2002 Cookie Policy and adopt the NITC Web Cookie Policy. Mr. Loewenstein motioned to repeal the 2001-2002 Cookie Policy and to adopt the NITC Cookie Policy; seconded by Ms. Donley.

Mr. Moravec reported on Citizen Notification If Breach of Identity (LB 876). He indicated LB876 provides methods of notification if there is a breach. He said he is going to meet with Ms Beverly Neth, Director of the NE Department of Motor Vehicles (tentatively November 15, 2006), to iron out the contract language regarding this legislation.

Mr. Bill Bidrowski gave the contractor's report. Mr. Bidrowski reported on the Board of Public Accountancy grant application. The project is in the late stages of testing. Mr. Brian Stevenson indicated a launch date decision will be discussed at a meeting on October 13, 2006.

Regarding the DAS – State Personnel grant application, DAS has an applicant tracking system RFP in rough draft form expected to be released in the next 30 days.

Regarding the Johnson County grant application, training will begin this month, however the entire project may take until the end of 2007 to complete. The Technical Review Committee has requested Johnson County comply with NITC GIS Standards and asked that they work with the State's GIS Coordinator to accomplish this. Mr. Loewenstein motioned to stipulate that the release of grant funds will be authorized when the State GIS Coordinator ensures the Board Johnson County has met the State GIS Standards; motion seconded by Mr. Freimuth.

Mr. Stevenson gave an update on the VISA Operating Regulations – charging fees through the Portal. The regulation in question is “A merchant that charges a convenience fee must ensure that it is a flat or fixed amount, regardless of the value of the payment due”. There is a discrepancy in the definition of ‘convenience fee’ by the parties involved. Mr. Stevenson indicated a conference call is scheduled for October 24, 2006 to hopefully resolve this issue. The parties involved in the conference call are the State Treasurer, NIC, First National Bank of Omaha and VISA.

Mr. Stevenson presented a ‘concept document’ on the CIO – Nebraska One Stop Business Registration Portal. Mr. Freimuth questioned the State’s policy on advertising on the State’s Web site. Chairman Gale indicated he and Mr. Moravec may look into it. Ms. Herbers asked what the time line is on this project and Mr. Stevenson indicated he would have that information in the near future. She also asked if the staffing levels of Nebraska.gov are in line with Nebraska.gov’s Business Plan. Mr. Stevenson described the current staffing levels and indicated they were on track.

Mr. Ptacek introduced and gave a history of the NE Department of Motor Vehicles – Addendum Seven. Mr. Ptacek recommended any further action be postponed until a resolution is reached regarding the VISA procedures question. He recommended a letter be written to Scott Yank, Deputy State Treasurer, from the NE State Records Board asking for a recommendation in writing when the resolution is reached by all parties. Mr. Loewenstein motioned to send a letter to Scott Yank asking for an explanation of the resolution and a recommendation, in writing, when it is reached; seconded by Mr. Yank.


